

CAMPGROUND SAFETY RULES, USE, AND EXPRESSED ASSUMPTION OF RISK DISCLAIMER

Please read carefully. If you have any questions please contact the Camp Manager.

ENTRY CODE: The front gate is open during the day, but closed at night for security. Access Code to open the front gate is “**1897**”.

BATHROOMS / SHOWERS: Restrooms and showers are available behind the Dining Hall, and in the Pool House. Access code to the bathrooms is “**1897**”.

WiFi: The Camp has two WiFi routers, “Camp_AG! Poolhouse” and “Camp_AG! Tabernacle”. The password is “Camp_AG!” for both.

QUIET HOURS: Quiet hours are **10pm – 7am**. Violators may be asked to leave without refund.

NO SMOKING: Smoking is not permitted on the property or in any buildings.

CAMPFIRES: Fires can only be built in designated fire pits /grills. Fires can NEVER be left unattended. Campfires must be extinguished by midnight. Campfires may be prohibited during high fire danger alerts.

PET POLICY: Dogs must be leashed at all times and have current shots. Coyotes have been seen in the Campground, and dogs must never be left unattended.

VEHICLE/GUEST POLICY: Vehicles/Guest per site are as follows: (\$10 per addition guest/vehicle)

RV: 1 Vehicle/4 Adults **Tents:** 1 vehicle/ 2 adults

Cabins: 1 vehicle/4 adults **Brigham:** 2 vehicles/6 Adults

Ikeda: 2 vehicles/6 adults **Gillespie:** 2 vehicles/8 adults **Cusack:** 3 vehicles/10 adults

ALCOHOL USE: Alcohol is only permitted in your overnight camp site. All traffic laws apply inside the Camp. Our speed limits are low for the safety pedestrians and children. Do not drink & drive.

POOL USE 11AM - 6PM* Participation in any water activity is done at your own risk. The following rules must be understood and followed for use of the pool.

- **No lifeguard** is provided at the pool.
- A minimum of ONE adult, 18 years or older must be present whenever the pool is in use.
- A parent or legal guardian must accompany children under 16.
- Do not consume alcohol while in pool area.
- Rescue equipment is located at the pool side.
- The swimming area must be maintained in sanitary manner.
- If you notice a problem with the water quality or absence of water rescue equipment, please notify camp immediately.

ASSUMPTION OF RISK: All guests and visitors assume all risks and danger incidental to camping in a rustic outdoor environment: including specifically, (but not limited to), the danger of being injured while participating in recreational activities such as swimming, hiking, and outdoor activities at the campground, being injured/killed by wildlife, being injured/killed as a result of inclement weather conditions, and/or damage of property due to falling rocks/trees. Campers agree that the campground and its owners, agents and employees are not liable for injuries or property damage resulting from such risks and danger.

Camp Arroyo Grande provides staffing for administrative and guest services only. We do not provide emergency service personnel. **In the event of an emergency, call 911.** Also report your emergency call to the Camp Manager as soon as practical.
